## MEMORANDUM OF ASSOCIATION

**Name :** The name of the Society is "The Bapatla Education Society, Bapatla".

**Office :** The Registered Office of the Society will be located within the Municipal limits of Bapatla town, in the premises of The Bapatla College of Arts & Sciences, Bapatla.

**Objects of the Society :** The objects of the Society are :

- a) to found and run educational and cultural institutions to impart education in arts, sciences and all or any of the technological subjects at Bapatla.
- b) to aid any such Institutions that are run in the Guntur District;
- c) to act as a trust board to accept endowments, bequests, donations, subscriptions etc., and other transfers of property made to the Society and administer them in accordance with the terms agreed to;
- d) to raise necessary funds to maintain educational Institutions under its management and administer the same;
- e) to acquire and dispose of properties for the benefit of the Society;
- f) to arrange extension lectures in one or all branches of knowledge;
- g) to print and publish journals or magazines with articles contributing to growth of knowledge, human understanding and culture.

4. The Governing Body of the Society shall, for the present, consist of the following members and their term of office shall be three years from the date of registration, i.e., 17-10-1962.

## THE BAPATLA EDUCATION SOCIETY BAPATLA MEMORANDUM OF ASSOCIATION

1. **Name** : The name of the Society is "The Bapatla Education Society, Bapatla".
2. **Office** : The Registered Office of the Society will be located within the Municipal limits of Bapatla town, in the premises of The Bapatla College of Arts & Sciences, Bapatla.
3. **Objects of the Society** : The objects of the Society are :
  - a) to found and run educational and cultural institutions to impart education in arts, sciences and all or any of the technological subjects at Bapatla.
  - b) to aid any such Institutions that are run in the Guntur District;
  - c) to act as a trust board to accept endowments, bequests, donations, subscriptions etc., and other transfers of property made to the Society and administer them in accordance with the terms agreed to;
  - d) to raise necessary funds to maintain educational Institutions under its management and administer the same;
  - e) to acquire and dispose of properties for the benefit of the Society;
  - f) to arrange extension lectures in one or all branches of knowledge;
  - g) to print and publish journals or magazines with articles contributing to growth of knowledge, human understanding and culture.
4. **Membership** : This Society shall consist of the following classes of Membership.
  - A) Patrons : Those that pay Rs. 10,000/- or more shall be Patrons of the Society with hereditary rights under the Law of Promogeniture.

- B) **Donors** : Persons who pay Rs. 5,000/- or more shall be called Donors with membership for life.
- C) **Life Members** : Those that pay Rs. 1,000/- or more as donation are called Life-Members.
- D) Representatives of persons, societies and trusts, Municipal or local bodies who benefit this Society by donating Rs. 20,000/- or more in cash either in a lumpsum or in instalments or property worth Rs. 20,000/- or more of assure an annual contribution of Rs. 1,000/- or more for 20 years, the conditions and terms of representation being regulated by agreement between the Governing Body of this Society and the said persons or trusts or societies. Municipalities or local bodies, subject to the ratification of the General Body of this Society at a special meeting.
- E) A member may be admitted at least five days before the election of the Governing Body.

#### 5. Governing Body :

- i) **Membership** : The Governing Body of this society shall consist of not less than fifteen persons of the following categories.
- a) Patrons
  - b) Donors
  - c) Life-members elected in the ratio of one for every 5 members present and voting. The President shall have power to conduct election in a manner he thinks fit.
  - d) Representatives of trusts, societies, persons, municipalities of local boards, with whom this Society enters into agreements.
- ii) **Election** : The members of the Governing Body shall be elected once in every three years at a special meeting held in the month of April generally. They shall hold Office for a period of 3 years from the date of election, or until the new Governing Body is elected. The 1st election shall be held before the end of October, 1965; but the elected body shall be in office till the next election to be held in the month of April 1969.

- iii) The Governing Body shall elect a President, two Vice Presidents a Secretary, a Joint-Secretary and a Treasurer from amongst themselves within one month from the date of general election.
  - iv) No member who has a near relatives as an employee of the Society or institutions owned, run or managed by it shall become an office bearer there of.
- Explanation** : Near relative shall mean and include father, mother, brother, sister, husband, wife, children, paternal uncle, maternal uncle, paternal aunt, maternal aunt, nephew, niece and son-in-law of an employee.

#### 6. Powers of the Governing Body :

- a) The Governing Body shall be the custodian of all properties belonging to the Society.
- b) An Appointments Committee consisting of the President, Secretary, Treasurer and Joint-Secretary, besides the representatives of the University and State Government. if any, shall appoint necessary members of the staff whose monthly remuneration is Rs. 75/- and more; and shall have power to determine the conditions of appointment, promotion and service of its staff.
- c) The Appointments Committee shall have the right of dismissal of the staff. All appeals against punishment shall lie to the Governing Body within a month of the orders of punishment and the decision of the Governing Body is final.
- d) The Governing Body shall have the right of passing resolutions for the proper administration of all institutions under its control and management.
- e) The Governing Body shall submit the annual budget for approval of the General Body.
- f) The Governing Body shall make arrangements for annual audit of accounts by the auditors selected by the General Body.
- g) The Governing Body shall place the audit report of the past year and the budget for the next year before the annual General Body meeting of the Society.

h] The Governing Body shall have the right to admit or refuse admission to any person to become a member of the Society without assigning any reasons.

i] The governing Body Shall have the right to provide and make rules and regulations for the internal administration of the institutions run by the Society from time to time and to constitute committees to exercise all or any of the powers of the Governing Body that may be delegated to them by a resolution.

j] There shall be a College Committee of The Bapatla College of Arts and Sciences, Bapatla. It shall consist of the following members.

i) President, Secretary, Joint-Secretary & Treasurer of the Bapatla Education Society by virtue of their offices.

i) Principal of the College

ii) One member of the Staff of the College.

iv) Two representatives of the Andhra University.

v) One representative of the Govt. of Andhra Pradesh.

vi) Representatives of the Eastern Choultry as per the Decree in O.S. 27/63.

vii) Managing Trustee of Annavarapu Pundareekakshudu Scholarship Fund Trust.

k] President, Secretary, Joint-Secretary and Treasurer shall be the office bearers of the College Committee in their respective capacities.

l] Any casual vacancy in the Governing Body or the College Committee may be filled up by co-option by the Governing Body for the unexpired period from the members of that class in which the vacancy arises.

#### **7. President :**

a) The President shall be the person to sue or to be sued on behalf of the Society.

b) The President shall appoint the members of the staff for any institution run by this Society whose monthly remuneration is below Rs. 75/-

c] The President shall have the right of meting out punishment by fine or suspension to any of the erring members of the staff and shall be primarily responsible for the discipline in the institution run by the Society.

d] The President shall preside over all the meetings of the Governing Body and General Body.

#### **8. Vice-President :**

a] In the absence of the President in the meeting of the Governing Body or General Body, the members present shall elect one of the Vice-Presidents to preside over the meeting and if only one Vice-President is present, he shall preside over such meetings.

b] The President shall, when he is absent from headquarters for over a period of a fortnight delegate all his powers to any one of the Vice-Presidents.

#### **9. Secretary :**

a] The Secretary shall be in charge of all the records of the Society and maintain its accounts.

b] The Secretary shall convene the meeting of the General Body and Governing Body on his own initiative or on requisition signed by 1/3rd of the members on rolls for the meeting of the General Body and that of the Governing Body.

c] The Secretary shall sign all cheques relating to the Society along with the Treasurer.

d] The Secretary may incur expenditure of not more than Rs. 500/- not provided for in the budget but any such expenditure must be got ratified in the next meeting of the Governing Body. In the event of such exependiture not being ratified, the Secretary shall reimburse the same.

e] The Secretary shall carry out the resolutions of the General Body and the Governing Body.

f] The Secretary shall prepare the annual budget for the ensuing year and place the same for approval before the Governing Body.

g) The Secretary shall incur all sanctioned expenditure.

h) The Secretary shall place before the Governing Body in its monthly meeting the expenditure incurred in that month, the action taken regarding the implementation of the resolutions of the General Body and the Governing Body and the correspondence regarding the institutions run by the Society.

i) In the absence of the Secretary, the Joint-Secretary shall exercise his functions and in the absence of both, the President shall exercise the functions of both.

j) The Secretary shall make available for inspection by any of the members of all the accounts and records within 3 days after notice to the Secretary, during office hours fixed by the Secretary.

#### 10. Joint-Secretary :

a) He shall be the Correspondent of the College.

b) He shall supervise the day-to-day functioning of the College.

c) He shall exercise such other powers as are delegated by the Secretary.

#### 11. Treasurer :

a) The Treasurer of the Society shall be in-charge of all its and those of the college funds and shall honour all bills signed by the Secretary. He shall not have more than Rs. 1000/- in cash on hand. The balance shall be deposited in a bank in the name of the Society.

b) The Secretary and Treasurer shall jointly operate the accounts of the College and Society.

#### 12. Qualifications for membership :

Any person not being a minor, lunatic, born idiot, undischarged insolvent, convicted of an offence involving moral turpitude, shall be eligible to become a member of the Society subject to the provisions of the Articles of the Association. Any person who is a major and who is of sound mind and is not disqualified by any of the disabilities enumerated under Art. 13 is eligible to become a member of the Society subject to the provisions of the Articles of this Association.

#### 13. Disqualification to become members of the Society :

The following persons are disqualified to become members of the Society.

i) A Lunatic

ii) Born idiot

iii) The person who applies to be adjudged insolvent

iv) An undischarged insolvent

v) A person convicted of an offence involving moral turpitude

vi) An employee of the Society or any institution run or managed by it.

vii) Any person who has subsisting interest in any contract with the Society.

viii) Any person whose interests are adverse or who works adversely to the interests of the Society.

#### 14. Termination of membership :

The membership of any person may be terminated in the following manner :

i) By resignation of death.

ii) By a resolution of the Governing Body passed by the majority of its members subject to the approval of the General Body by 2/3rd majority of members present and voting for reasons mentioned in Art. 13 supra.

#### 15. The General Body :

i) The General Body shall meet every year ordinarily in the month of April to transact the following business :

a) to take stock of the activities of the previous year.

b) to pass annual budget.

c) to approve the audit report of the previous year.

d) to issue instructions, if any, to the Governing Body and the office bearers for the proper administration of the institutions run by the Society.

ii) The General Body shall also meet in September and December to issue instructions, if any, to the office bearers for the proper administration of the institutions run by the Society.

#### 16. Powers of the General Body :

The General Body shall have all powers necessary or incidental to carrying out the objects of the Society, and in particular, the General Body shall have the following powers :

- a) to acquire property for the benefit of the Society or any of the institutions run by it.
- b) to sell, mortgage, lease or otherwise transfer any property of the Society.
- c) to deal with the endowed properties, subject to any conditions of such endowments.
- d) to raise loans for the purpose of the Society or run raffles or dramas for the benefit of the Society.
- e) to delegate any of its powers to the Governing Body or to any of its office bearers.
- f) to elect the members of the Governing Body.
- g) to approve agreements between the Governing Body and persons, Societies or Trustees, Municipalities or Local Bodies who donate monies or properties to the Society.
- h) to write off any arrears or to authorise the President to compromise any litigation or ratify any of its decisions.
- i) to appoint auditors.
- j) to have all the residuary powers not covered by the Articles of Association.

#### 17. Meetings :

a) Ordinary meeting of the General Body :

it shall be convened with 15 clear days notice by the Secretary except in the case of newly enrolled members. The meetings convened under Art.

15 are called the ordinary meeting.

b) **Requisition Meeting** : The Secretary of President shall convene the General Body meetings on the receipt of requisition signed by at least 1/3rd of the members from among members of the Society; if the Secretary of President does not serve the notice of the meeting within 72 hours of the receipt of the requisition, the persons who signed the requisition may convene the meeting with 7 clear days notice.

c) **Special Meeting** : There shall be 30 clear days notice of the General Body meeting for the purpose of election of the Governing Body. Notices of the meeting should be issued by Registered Post. This does not apply to members admitted under Act. 4 (E).

d) **Extra-ordinary Meeting** : The Secretary or the President may convene any extra-ordinary meeting on his own initiative to transact any matters of urgent importance, with 3 clear days notice.

#### 18. Governing Body :

a) Ordinary meeting of the Governing Body may be convened by the President or Secretary with at least 3 days notice. The Secretary of President can convene the meeting or the Governing Body to discuss matters of urgent importance with a day's notice.

b) **Requisition meeting** : The secretary of President shall convene a meeting of the Governing Body on requisition of at least 1/3rd of the members of Governing Body; if the Secretary or President does not serve notice within 48 hours of the receipt of the requisition, the signatories may convene the meeting of the Governing Body with 3 clear days notice.

#### 19. Quorum :

a) The quorum for all meetings of the Governing Body shall be 1/4th of the total strength. But the quorum for General Body shall be 1/5th of the total strength.

b) If there is no quorum in any meeting within 30 minutes from the time notified for the meeting, the meeting shall be adjourned. For the adjourned meeting no quorum is necessary if it is adjourned to a date within a week.

20. A resolution once passed cannot be brought up for discussion, review, amendment, revision or cancellation within a month from the date of the resolution, provided not less than half of the number on rolls shall attend the meeting.
21. No-confidence motion : All or any of the office bearers may be removed by resolution passed by a 2/3rd majority of the members of the General Body on rolls in a meeting called specially for that purpose. No such resolution can be passed within one year from the date of election of such office bearers. Notice of requisition of such a meeting shall be signed by at least 1/3rd of the total number on rolls. No second resolution of no confidence can be brought within one year of the defeat of the no confidence resolution.
22. The Society shall have power to alter, add to or omit any of the bye-laws in a special meeting of the General Body by a 2/3rd majority of its members without any retrospective effect.

In pursuance of the resolutions passed in a Special meeting and 31-01-2001 with regard to the proposed amendments to the Articles of Association, the following Articles are incorporated to the existing articles of Association.

- 22A. However, in case of any direction from the Government/ Departments concerned, 2/3 majority of its members present at the meeting is sufficient.
23. Funds of the Society shall be invested in accordance with the provisions of Section 13 (1) (d) r.w.s. 11 (5) of income Tax Act, 1961.
24. The Society would be irrevocable.
25. The Accounts of the Society will be audited by a Chartered Accountant every year.
26. The income and the funds of the Society shall be solely utilised for the furtherance of the objects of the society and no part of it shall be distributed among the members of Trust/Society by way of profit or dividend or otherwise.
27. In the event of dissolution of the Society, the funds remaining after the discharge of all its liabilities shall be transferred to another Society/Institution/Association having similar objects and registered with Commissioner of Income Tax U/S 12A and U/S 80G of Income Tax.
28. The benefits of the Society are opened to all irrespective of caste, community, religion etc.,
29. No amendment to the trust deed/ Memorandum of Association/ Bye-Laws of the Society shall be carried out without prior approval of the Commissioner of Income Tax.
30. The activities of the Society / Institution / Trust shall not be carried out anywhere outside of India.

## AMENDMENTS

In pursuance of the resolutions passed in a Special meeting and on 29-03-2021 with regard to the proposed amendments to the Articles of Association, the following Articles are incorporated to the existing Articles of Association.

### Amended Bylaw Article 4 as follows :

#### Article 4, Membership :

- a) All the existing Patrons (List enclosed) shall continue to be as such to be legally also called General Body. All the parents Patron members shall hold office during their life time with hereditary rights without there being any classification with equal status as General Body Members of the Society.
- b) No new member shall be admitted to the General Body unless he/she contributes Rs. 50,00,000/- (Rupees Fifty Lakhs only) to the common good fund of the Society and by paying application fees of Rs. 1,00,000/- subject to the approval of 2/3rd members of the General Body present on rolls. The said amount must be paid by way of Demand draft drawn in favour of 'The Bapatla Education Society, Bapatla'.
- c) The General Body shall have a right to admit or refuse admission to any new person to become a member of the Society without assigning any reasons. In case the application for admission is rejected application fees of Rs. 1,00,000/- is non-refundable.
- d) Any existing member who intends to retire due to old age/ infirmity or any other compelling reasons, he/she may transfer membership to any of his/her family members to become the General Body member of the Society. The moment his/ her application is accepted by the General Body the transferee will be treated as General Body Member.
- e) Any member who intends to nominate his /her membership to any of his/her family members after death, he/she can nominate by making an application to the Society by mentioning the name of nominee. After his/her application is accepted in the General Body the membership will be transferred to the concerned nominee after his/her death. This nomination is revocable during the life time of the member.

Explanation : For the purpose of Art. 4 (d) & (e), family means son, daughter, grandson, grand daughter, daughter-in-low, son-in-low, wife and husband.

- f) If any member of the Society dies without executing any document, his/her eldest son/daughter will become the member of the Society. In case eldest son/daughter is not there or not inclined to take membership, the second son/daughter will become the member of the Society. If, the second son-/daughter is also not there or not inclined, the next son/daughter in order of age will become the member of the Society. In the absence of nomination, the family member of the deceased member have got right to choose any one of them and make an application to the Society to appoint the said person of their choice as member of the Society by producing consent letters from all the family members of the deceased. After the said application is accepted by the Genral Body. the concerned person will become the member of the Society.
- g) I case any member has no children or adopted son /daughter, he/ she can nominate one of his/her siblings or the children of the siblings for his/ her membership of the Society. In case no such application is submitted his/her membership will be terminated.
- h) Applications for new membership of the society shall be placed before the General Body only in its first meeting of every calendar year.
- i) Application received by the heirs of the deceased member for the membership shall be placed before the General Body in the first meeting convened after such receipt.
- j) Applications received for transfer of membership under Article 4 (d) shall be placed before the General Body in the meeting convened in the months of June, September, December and March respectively.
